**DAYCARE RULES AND REGULATIONS:**

- We accept dogs of all ages. Puppies must be over 12 weeks and on a vaccination program. Puppies or shelter dogs must have been in the home for at least two weeks prior to attending daycare.
- All dogs over the age of six months must be spayed or neutered.
- All dogs require up-to-date vaccinations. Proof of vaccinations or titer testing is required.
- Dogs that are currently ill or injured are not permitted at daycare. Owners certify by signing this application that their dogs are in good health.



- All dogs must be non-aggressive and not food or toy possessive. Owners certify by signing this application that their dog has no history of harming or threatening another animal or person.
- Pick-ups must be completed by 6:00pm. Late fees for late pick-ups apply at a rate of \$15.00 for every fifteen (15) minutes past 6:00pm. No exceptions.
- Daycare passes have no cash value, are non-transferable and non-refundable. All passes expire in thirty (30) days from the date of purchase.

**INJURIES & ILLNESS:** At VLP GROOMING & SPA, we strive to provide your dog with excellent care and a fun experience during their stay. Although animals are supervised at all times, injuries can still occur while dogs are playing together such as scratches, cuts or sprained joints. Such injuries are rare, but they happen at all doggie daycares. In addition, while infrequent, dogs can get into fights, even under close supervision. Common areas for bites as a result of these fights are the snout, ears, tuft of the neck and paws. At VLP GROOMING & SPA, we have procedures to screen dogs for aggressive behavior and we do not allow aggressive dogs to play with other dogs. However, even the friendliest of dogs can get into fights with very little or no warning. In addition to injuries, it is possible for dogs to transfer illness such as upper respiratory infections and kennel cough, even with the required vaccinations and boosters. This is just like at a daycare for children where illness such as pink eye and the flu can be transmitted from one child to another. Such illnesses do not occur often and all dogs must have the necessary vaccinations to check-in.

### **WAIVER and AGREEMENT:**

1. I hereby represent that I am the legal owner of the dog(s) described on this registration form to use the services provided by VLP GROOMING & SPA.
2. I agree that VLP GROOMING & SPA will not be liable for any claims of injury, illness, damage or death to my dog(s) during any stay and that under no circumstances will VLP GROOMING & SPA be liable for consequential damages.
3. I certify that I have informed VLP GROOMING & SPA of all dog and human aggression. I agree that I am responsible for any harm caused by my dog(s) while in the care of VLP GROOMING & SPA. I shall indemnify VLP GROOMING & SPA against any claims made against it or for losses or damages suffered by VLP GROOMING & SPA as a result of my dog(s).
4. I hereby represent that my dog(s) is in good health and has not been ill with any known contagious diseases within the past thirty (30) days.



5. I recognize that the health of the dog(s) is the owner's responsibility. I hereby represent that all required vaccinations (rabies, distemper, Bordetella and parvovirus) are up to date. I will also continue to ensure that the required vaccinations will be kept up to date for as long as my dog(s) attend daycare at VLP GROOMING & SPA. In addition, I hereby represent that my dog(s) has flea/tick preventive treatments applied regularly.
6. I understand that, in the event my dog appears to be ill or at significant risk of experiencing a medical problem, VLP GROOMING & SPA will attempt to contact me for instructions prior to seeking veterinary care. If I cannot be reached, I agree that VLP GROOMING & SPA may use its reasonable discretion in seeking veterinary care on my behalf and I will be responsible for all related expenses. I understand that VLP GROOMING & SPA will attempt to use my preferred veterinarian, but if my preferred veterinarian is unavailable or other circumstances mandate, I authorize VLP GROOMING & SPA to use the veterinarians of its choice. I agree that VLP GROOMING & SPA will not be liable for the actions and decisions of the veterinarian. I also agree to be responsible for any reasonable fees assessed by VLP GROOMING & SPA for emergency care and transportation.
7. I authorize my veterinarian to share the medical records of my dog(s) with VLP GROOMING & SPA and other veterinarians. I assume full responsibility for payment of all veterinarian services rendered, including, but not limited to diagnosis, treatment, necessary grooming, medical supplies and transportation. I agree to make such payments directly to the attending veterinarian or reimburse VLP GROOMING & SPA if direct payment cannot be made.
8. I understand that VLP GROOMING & SPA fees and packages are non-refundable and non-transferable.
9. I agree that my dog(s) may be videotaped, photographed and/or recorded. VLP GROOMING & SPA shall be the exclusive owner to the results and proceeds of such media.
10. VLP GROOMING & SPA reserves the right to permanently remove a dog from care at any time to ensure the safety of other dogs, as well as staff.
